Church on the Move is pleased to invite you to our **6<sup>th</sup> Annual COTM Golf Invitational**. On Saturday, June 26<sup>th</sup>, **Emerald Falls Golf Club** in Broken Arrow will be ours for the day. Emerald Falls has been ranked by Golf Digest as one of America's best public courses and we're very excited to have our event here this year. Whether you're an excellent golfer or just a beginner, you and your friends and family will be sure to have a blast at this event. Husband-wife, father-son, or mother-daughter teams are welcome to join in on the fun. This is a "scramble" or "best ball" tournament, meaning that everyone in the foursome gets to play each shot from the best ball hit by your group.

**Group A** will play the first round. If you consider yourself to be a *moderate to competitive* golfer this round is for you. **Group A** will **check-in between 6:30 – 7:00am on Saturday** for the early "shotgun start". **Group A** will finish with lunch, then an awards ceremony.

**Group B** will play the second round. This round is for golfers of any level. If you're a beginner to moderate golfer, you'll fit right in. **Group B** will start their day by **checking-in between 11:15 – 11:45am**, followed by lunch. After lunch you will have an opportunity to warm-up on the driving range and at the putting green.

### ***Perks...***

We'll start with lunch, Emerald Falls own Chef Mark will be preparing a delicious meal for the event. Jamba Juice smoothies will also be available throughout the day. Fabulous prizes will be awarded for the 1st Place, 2nd Place, and 3rd Place Foursomes in both Group A and Group B, in addition to the Hole-in-One, Longest Drive, Closest-to-the-Pin and Putting Contests. ### ***Cost...***

The cost to play in the *COTM Golf Invitational* is **\$65** for all players ages 18 and up. Our *junior rate*, for ages 14 to 17, is **\$55**. Players 60 and older are eligible for our *senior rate*, which is also **\$55**. This is an all-inclusive tournament, the price covers green fees, carts, drinks, lunch and plenty of giveaways. No refunds will be given in the case of inclement weather, however we do have a rainout date scheduled for Saturday, July 10<sup>th</sup>.
